MINUTES OF THE PREVIOUS MEETING.

URGENT ITEMS

HIGHWAYS – The pothole on the roundabout in Pound Road has been repaired, however others have now appeared and have been reported to Highways. The recent flooding at the cross roads was discussed and was reported to Highways.

STREET LIGHTS – Unfortunately, since the last meeting there are further reports of street lights not working, it would appear that at least one is beyond repair. The Clerk contacted SEB and asked for quotes to replace each type of street light in the parish.

PLANNING.

16/00668/FULLN – Single storey timber stable block erected on a concrete slab and an improved track – Townsend Manor Farm. 1 NO COMMENT, 4 SUPPORT.

16/00740/FULLN & 16/00741/LBWN – First floor extension over existing single storey extension to provide two additional bedrooms and minor internal alterations to existing first floor bedrooms – Chapel House, Farley Street, Nether Wallop (Over Wallop) - SUPPORT

16/00752/FULLN – Single storey front and rear extensions with attic conversion providing additional bedrooms and bathroom and family room; change external materials to render and re-roof in slate tiles, install new dormer windows and rooflights – Hemasaro, Wallop Road, Grateley – SUPPORT

16/00656/TREEN – Yew – reduce overall canopy by up to 3m – Roumain Cottage, Station Road, Over Wallop. The Parish Council would like to see the report from the tree surgeon as this is a very old tree in the Conservation area. OBJECTION.

LEISURE REPORT

The Chairman reported that Fowlers Architects have drawn up the plans for the new pavilion, these have been distributed to the Parish Councillors for comment. Fowlers Architects have offered to get the plans ready for the planning application.

The Chairman reported that a parishioner offered to organise event to mark the Somme centenary on the playing field as well as to raise money for the new pavilion. Further details will be made available nearer the time.

PARISH HALL

Cllr Taylor Firth reported that at the recent Parish Hall Management Committee meeting the accounts for the year 2015/2016 were approved. The Parish Hall made a $\pounds 2,800$ profit. Booking are beginning to pick up and the carpets are due to be cleaned.

FOOTPATHS - The footpaths are all walkable but still muddy

PALESTINE – Nothing to report.

KENTSBOROUGH – Nothing to report.

POUND ROAD – It was suggested that Bargate Homes are invited to the Parish Council AGM to give a presentation on the development. This was thought a good idea. The Chairman will invite them to the AGM.

The Chairman reported an incident in the village allegedly involving a construction vehicle to the Bargate site and damage to a property. The home owner was directed to the site office and she believed the matter is being dealt with. End note: witnesses state that the damage was not done by construction vehicles but by fast car at the corner forcing a larger vehicle off the road.

PRINTERS' PLACE – Cllr Roberts reported a further problem with dog fouling in Printers Place and he received complaints from residents. The Clerk suggested that residents contact TVBC and request that the Dog Warden pays a visit.

MEMBERS OF THE PUBLIC

Mr Macey raised the issue of the overgrown hedge on the main road and the obscuring of the sight lines when exiting Station road at the cross roads. The Chairman reported that there is a history on this particular hedge and pointed out that the property is actually in Nether Wallop. This was noted. End note: the complaint passed on to NWPC who state that the sightlines are clear.

Mr Flippance commented that the only way to stop dog fouling on the Playing Field was to ban dogs. This was noted.

The Chairman thanked everyone for coming and closed the meeting.
