WELCOME.

The Chairman welcomed everyone to the meeting.

DECLARATION OF INTEREST.

Cllr Glover declared an interest in planning application 15/03091/FULLN

MINUTES OF THE PREVIOUS MEETING.

The Chairman signed the minutes of the previous meeting as a true record. Proposed by Cllr Burden and seconded by Cllr Elliot.

URGENT ITEMS

HIGHWAYS – The Chairman reported that she had not received any further communication from Highways regarding the proposed traffic calming.

The Chairman reported that Ray Alborough, TVBC Highways had been in contact about the state of the verges in Evans close and Pound Road. A site meeting with Highways engineers is to be organised to look at the problem.

The parish council discussed the increasing poor state of the triangle at Craydown Lane. Cllr Glover spoke to the manager of the chicken farm. He asked the delivery firms not to use this route to the site. The large HGVs visiting the site should stop when work on the last chicken shed is finished. Unfortunately, the use of satnavs by HGV drivers unfamiliar with the lane is the main cause of the problem. It was noted that householders placing large obstacles on verges prevented HGVs from making a full turning circle.

FLOOD LIGHT BATTERIES – These were delivered soon after the previous meeting.

STREET LIGHTS – The Clerk was pleased to report that all but one of the streetlights are now working. SSE have also been in the village and cleaned all the streetlights. The Clerk has also asked SSE to repaint the numbers on the streetlights, as most of the numbers are not visible.

POLICE AND NEIGHBOURHOOD WATCH

The Chairman receives Hampshire Alert. Hare coursing, thefts form outbuilding and distraction burglaries are in the area.
