WELCOME. The Chairman welcomed everyone to the meeting.

DECLARATIONS OF INTEREST.

There was no declaration of interest recorded.

PARISH COUNCIL VACANCIES.

Cllr Mr T Burden reported that Mr Cavill may be interested in representing Palestine, The Clerk reported that Mr Dave Ling from Pound Road has expressed an interest in joining the Parish Council. Mr Dave Ling was present and introduced to the Parish Council. Mr Dave Ling will attend a few meetings and talk to the Chairman before committing to becoming a Parish Councillor.

COUNTY COUNCILLOR MR DAVID DREW.

MINUTES OF THE PREVIOUS MEETING.

CHAIRMAN'S REPORT.

TRAFFIC CALMING – Work on the Consultation is progressing. Test Valley Borough Council have provided a list of properties to assist with the survey so that residents can be verified. The Over Wallop Data Protection Policy will be adhered to. The PC is still waiting for approval of the proposed question from HCC so the consultation will now be held in January 2022. This will not delay the scheme timetable.

Hampshire County Council have been asked further questions on their response to the answers they gave on the meeting held on the 11th of October 2021 and to provide supporting material.

HAMPSHIRE ASSOCIATION OF LOCAL COUNCILS – The Clerk confirmed that he has contacted HALC about Over Wallop Parish Council re-joining.

EVANS CLOSE PLAY AREA – The Test Valley Borough Council Refuse Collector has reported that once again there is a large amount of human waste being put in to the wheely bins. No human waste products should be put in these bins. The Test Valley Borough Council Web Site has all the information on the free service they provide for the collection of human waste products.

THE QUEEN'S PLATINUM JUBILEE – A Parish Party to celebrate the Queen's Platinum Jubilee will be held on Saturday 4th June 2022. *Details will be made public in due course.*

PARKING AGREEMENT – The parking agreement for the residents in Moyles Place allowing occasional visitors to use the AEMG car park has been drawn up.

CLLR MR J TAYLOR FIRTH – Reported that the Wallop Parish Hall is running well. The Parish Hall Management Committee meeting has been postponed to 18th January 2022. The War Memorial project has been signed off.

CLLR MR C SMITH – Reported that the allotments are running smoothly. It is planned to hold an Allotment meeting in January 2022.
